We want to hear from as many people as possible. If you want to speak at a meeting, you will need to give us your comments, in writing, prior to speaking. We will also have comment cards, to be shared at each meeting. Please complete a comment card at the meeting, if you want to share your comments in that manner.

The Town Hall meetings are open to: Current 1915 (c) waiver participants, Individuals on a Waiver waiting list, Participant family members, Caregivers, Providers and the General Public. We must limit the number of attendees at each location due to capacity. All meeting locations are accessible.
